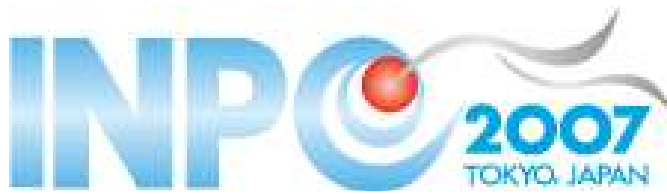

Plan B: 315,000 yen (including consumption tax)

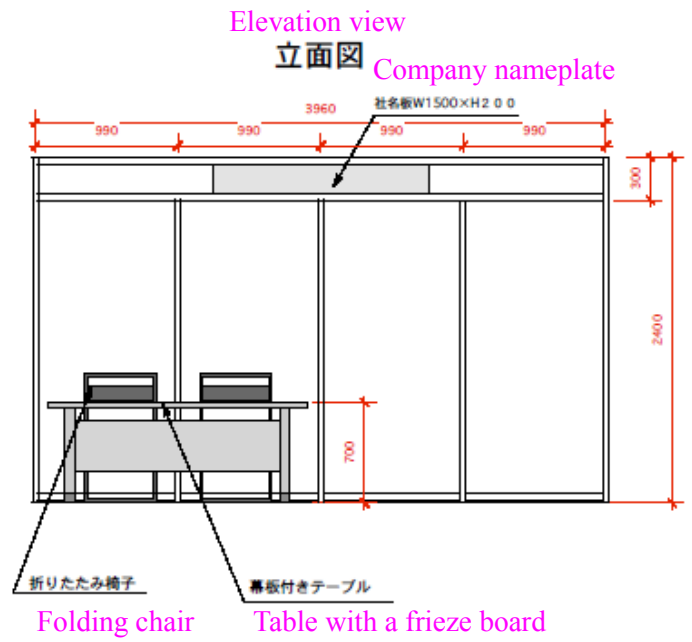
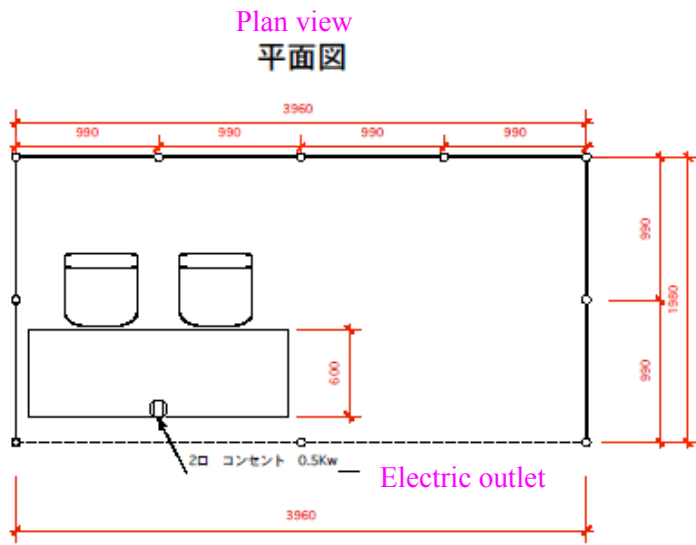
- System panel: 1,940 mm in width, 1,980mm in length and 2,400mm in height

Plan C: Space only: 262,500 yen (including consumption tax)

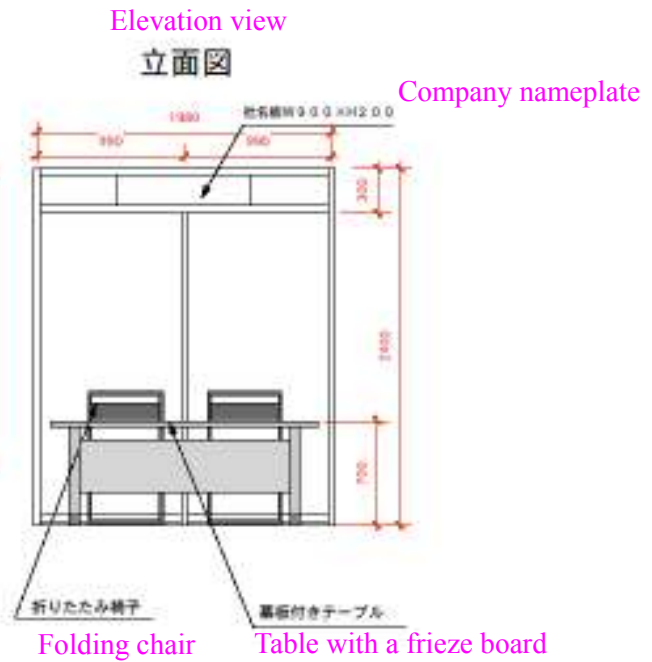
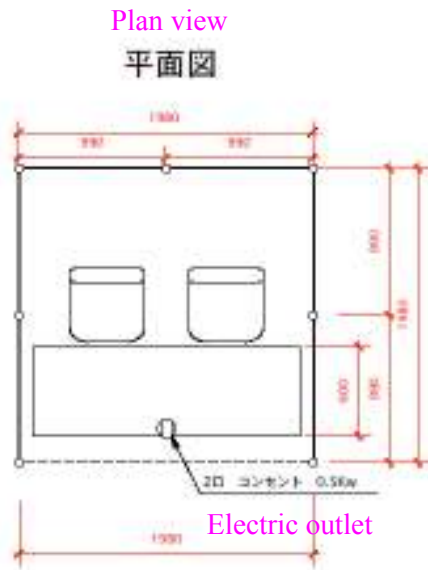

Booth image drawing

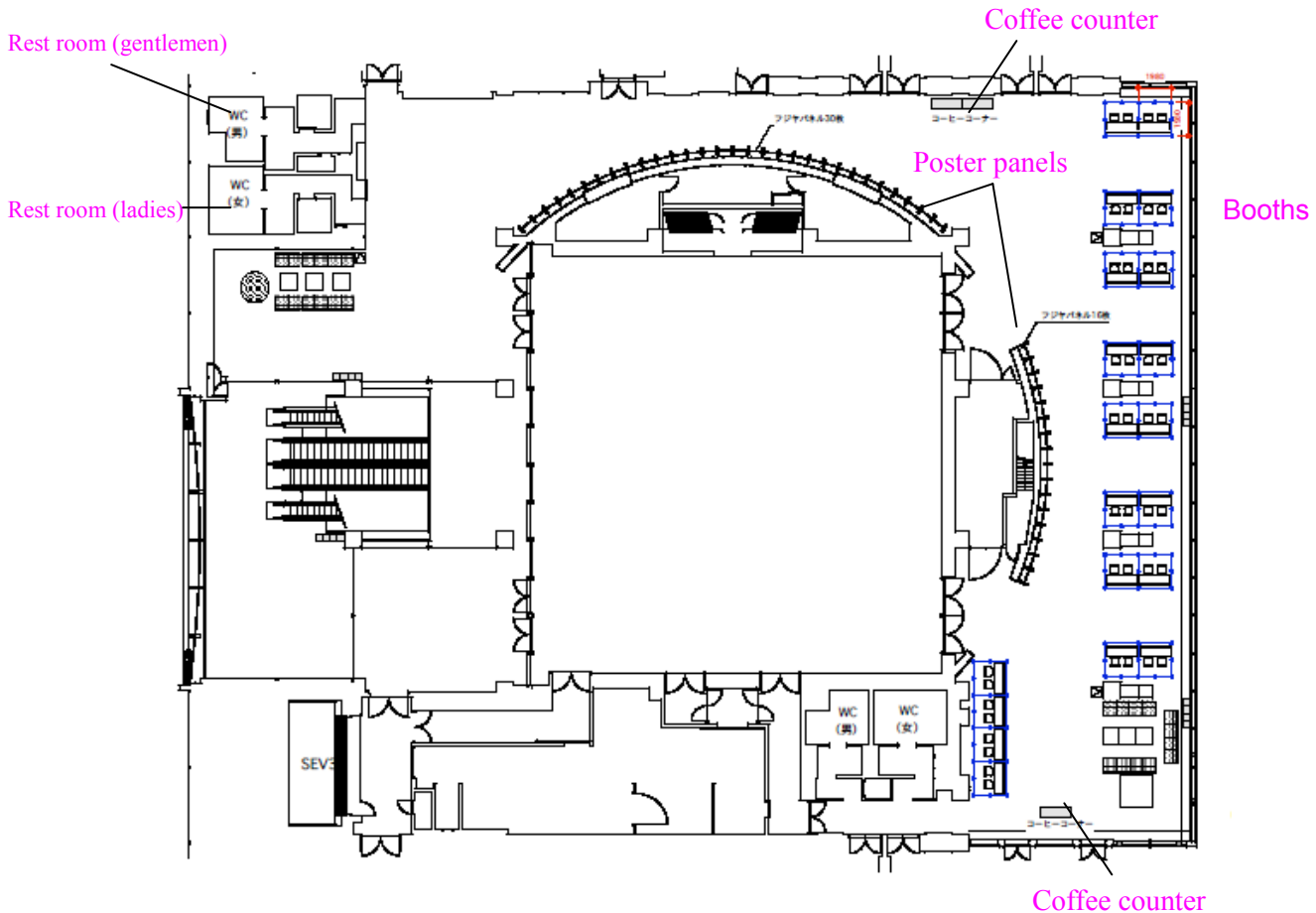
